#### a. Physical Accomplishment

To date, out of **1,746,199** target beneficiaries **1,016,060** Day Care Children and **10,258** children under Supervised Neighbourhood Play with total of **1,026,318 or 58.77%** were served nationwide. Procurement processes in some LGUs are still on-going.

#### b. Financial Accomplishment

From the total allocation of Php 4,427,077,000 for grants and admin cost, Php 2,159,137,988.44 or 48.77% was obligated by the 18 Field Offices to the LGUs to implement the program.

# c. 6th Cycle Nutritional Status (Partial Consolidated National Report)

Out of **2,231,361** target there are **2,001,142** or **89.68%** served children beneficiaries, there are 1,588,931 or 89.68% in normal weight status, 222,866 or 11.114% are underweight, 40,273 or 2.01% are severely underweight and 23,939 or 1.20% are overweight. Partial terminal status report: there are 1,565,901 or 78.25% are normal in status, 68,014 or 3.40% underweight, 10,709 or 0.54% severely underweight and 19,537 or 0.98% overweight.

#### d. 7th Cycle Nutritional Status (Baseline Partial)

Out of 1,746,199 target beneficiaries, 1,039,403 or 59.52 % children beneficiaries were weighed upon entry. There are 282,911 or 25.94% are normal in weight, 33,029 or 7.26% are underweight, 6,403 or 1.41 % are severely underweight and 5,820 or 1.28 % are overweight. Consolidation of baseline weight report is on-going at FOs.

#### II. Kabisig ng Kalahi

The progress and terminal reports of Kabisig ng Kalahi Community -Based feeding implementation for malnourished children in Davao City, Tagaytay City and Pasig City as indicated in below table.

- a. The Davao City rehabilitation of 61.66% based on their progress report shows that there was an improvement in nutritional results of beneficiaries after 2 months feeding implementation.
- b. Tagaytay City with 36.66% rehabilitation in 2 months indicates a slow progress due to transfer of residence and absences of beneficiaries resulting to drop-out status hence Kabisig recommends the replacement of the 11 drop-out.
- c. The terminal of report Pasig City shows that there was a success implementation of the program with 82% beneficiaries rehabilitated to normal nutritional status after 120 feeding days.
